## **COVID-19 Mobile and Permanent Testing Site Locations in Kankakee County and Surrounding Areas**

The Illinois Department of Public Health (IDPH) is hosting COVID-19 testing mobile sites in the coming weeks in/near Kankakee County. Details are as follows:

ALL IDPH mobile testing are FREE and open to all. You do not have to have symptoms or be sick to be tested.

Physical exam required prior to testing

Bring your insurance card, id, and proof of employment (if applicable)

Cost: Insurance will be billed. Cost for Out-Of-Pocket: \$165 for the exam, \$75 for the test, \$85 for Telehealth Follow-Up

\*Due to limited supplies, COVID-19 testing availability is very limited and may not be available all day\*

Requirements:

Answer a questionnaire online to find out if you qualify

Complete the registration form at [minuteclinic.com](https://www.minuteclinic.com). An appointment must be scheduled.

Insurance card (if applicable) and proof of identity is required.

Cost: Patients should not have any out-of-pocket costs. Insurance will be billed. If you do not have insurance, have your driver's license, state ID, or social security number so the cost can be submitted to the federal program for the uninsured.
